#### "Year 2006 - Year of India in Germany"

Rajani Panchang – LF 2000 a CSIR Senior Research Fellow pursuing her PhD in Oceanography (Geology). She is carrying out research at the National Institute of Oceanography, a CSIR lab at Goa and using marine microfossils to understand climatic variations like Monsoons and sea level fluctuations in Eastern Bay of Bengal. Currently **Rajani in Berlin** is pursuing advanced research at the Interdisciplinary Centre for Ecosystem Dynamics, in capacity of a DAAD Research Scholar. She provides an important piece of information on" Year 2006 - Year of India in Germany" to enrich our knowledge.

Iseem to have visited Germany at just the right time, so as to identify our own potentials as Indians through the eyes of a foreign observer. These lands may seem distant to many, but I share my newfound knowledge with our readers to make them aware of opportunities they might have not known before. It has been a learning experience which has helped me not only identify the lacunae in the Indian System, but also to value many of the resources we have but not exploited it in the best possible way. The Prime Minister of India was coming to visit me in Germany to ensure that all was fine with me. I soon overcame the joke when it was all over the media that the Prime Minister of

India, Dr. Manmohan Singh's visit to Germany would see him inaugurate the Hanover Trade Fair and then indulge in bilateral talks in Berlin, all of what is being called as "Year 2006- The Year of India in Germany". A rich and developed country like Germany, the world leader in R&D and technology earmarking an entire year as the Year of India in Germany!!!

In the year 2000, India and Germany adopted the 'Agenda for the Indo-German Partnership in the 21st Century'. Indo-German development cooperation covers wide-ranging areas including energy, environmental policy, sustainable

economic development, health and vocational training. At the previous Summit meeting in New Delhi in October 2004, both the countries set a target of doubling bilateral trade within five years The Indo-German Joint Commission on Industrial and Economic Cooperation since 2000 continues to focus on specific areas of cooperation for mutual benefit. The Indo-German Chamber of Commerce is not only celebrating its 50th anniversary this year, to promote economic cooperation between the two countries, but is also welcoming the opening of a German Trade Office in Bangalore, which will further promote German trade and investment in India. They also welcome the growing trend of Indian investments in Germanv. Apart from trade and economy, Germany and India have established a long and fruitful cooperation in Science and Technology. The Indo-German Science Circle has given new impetus to this cooperation and will further strengthen contacts between scientific and academic communities.

Now, coming to year 2006.... On the eve of Prime Minister Manmohan Singh's visit to Germany, Germany's new Ambassador to India, Bernd Mützelburg, said in a statement "India being the partner country of the Hanover Fair, the world's largest technology fair, partner country of the Frankfurt Book Fair, again the world's largest book fair and 'India' being the theme of the Bonn Biennale..... India is very high on Germany's agenda. And these are just some of the Indo-German events in Germany this year."

By taking centre stage as partner country in the world's largest technology fair (also inaugurated by the Indian Prime Minister) in April 2006, India got the best opportunity to showcase its innovative technologies, product quality and competitive spirit fuelling its economic success story. India's presence in Hanover also provided an important thrust for those Indian companies yet to firmly establish themselves in the European and world markets. Both countries also agree to actively promote our traditionally close cultural cooperation. India participated as the focus country in the Bonn Biennial Art Festival in May 2006. Bonn is the city where Indology was born in Germany in 1818. As such, Bonn has long been known as "Benares on the Rhine", and this Biennale went to prove even more why India was the theme of this year. Live concerts, exhibitions, film screenings, and readings by well-known Indian authors: the Biennale is a deluge of tremendous cultural diversity, unusual sights and sounds - as well as thoughts and meanings for the

Germans. The official statistics is nothing less than astonishing: over 10,000 people visited the various shows and functions; the troupes' and drama performances witnessed full houses. Indian theatre is becoming more and more popular abroad. Paradoxically enough, theatre in India is struggling for survival. In such a scenario, it can be estimated what a boost it might have been for the Indian theatre to receive the honour of being the theme at the Biennale. The two countries surely welcome the decision of the Indian Council for Cultural Relations to set up five rotating Chairs on Contemporary Indian Studies in various German Universities.

The Frankfurt Book Fair marks the confluence of great creative, commercial and organizational forces. India is the Guest of Honour or partner country at the Frankfurt Book Fair 2006 which has the theme 'opening minds and markets'. In a recent press conference, Jürgen Boos, director of the Frankfurt Book fair stated "At the Frankfurt Book Fair this October, the Indian publishing industry will display its potential at a large, joint stand covering 1,400 square meters. This will be complemented by numerous exhibitors from India's printing and IT industries in other halls. A series of trade-related events will provide exhibitors and visiting industry professionals information about the Indian market, which is currently more attractive for the publishing industry than practically any other country in the publishers Many German world. acknowledged India's Guest of Honour status by including more Indian books and books about India in their programmes. We are particularly pleased

that translations from India's regional languages make up more than one-fourth of the new literary releases. Among the list of 44 literary titles newly introduced on the market in 2006, 14 titles were translated from regional Indian languages apart from 50 new non-fiction titles on India with subjects as diverse as 'The Cuisine of the Maharaja' to the 'Bollywood Fan Book'. After all, we practice yoga and watch Bollywood films".

Starting this year, the Frankfurt Book Fair will hold a trend convention on its opening day. The topic for the first trend congress is 'India on the Rise'. Prominent speakers such as the Infosys-founder Narayana Murthy or Indian publicist Pankaj Mishra will discuss the Indian role in the world economy and the challenges of globalisation in India, and will examine India's book, IT and finance markets." What's more? India's Shashi Tharoor, UN undersecretary and author, will assume the patronage of the 'Frankfurt Book Fair Literacy Campaign', and a message that's written in Hindi will feature on this year's Frankfurt Book Fair reading mug. The message is "Duniya parhna hai kitab parhna" which is to say, "To read a book is to open up a new world".

Highlights of Indian participation in the fair include a gala inaugural programme on 3rd October 2006, scheduled at the Alte Oper in Frankfurt, an art exhibition on Indian manuscripts (Museum for Applied Art, Frankfurt), an exhibition of the paintings of Amrita Shergil's family (Haus der Kunst Museum, Munich), an exhibition of photographs (Fotografie Forum international, Frankfurt), an exhibition of IT and ICT capabilities in Indian book publishing, apart from the screening of Indian films at the Book fair cinema

and elsewhere. It would also include reading sessions by more than 30 eminent Indian authors including Vikram Seth, Amitav Ghosh, Arundhati Roy, Mahasweta Devi to Javed Akhtar.

For the German tourism industry also, India is a tremendous market. It observes that India's economic growth has been at a constant 6-8 percent for the past so many years, with prospects of reaching 10 percent in the near future.

The discussions during the Indian Prime Minister's visit identified that trade, investment, scientific and technological collaboration, including in the areas of infrastructure, energy and high technology areas such as space, form an important basis for the partnership. Both sides aim to further deepen their strategic and security dialogue and will work towards an agreement on bilateral defence co-operation. India's participation in the ITER initiative on fusion energy is an important part of the ongoing energy cooperation.

Apart from IT, German companies continue to invest in a broad range of industrial sectors such as machine tools, automotive, chemicals and pharmaceuticals, electrical and electronic manufacturing, but also in service sectors such as banking and insurance. A growing number of small and medium sized German manufacturing companies are taking up business in India.

The most common questions I faced were from the Indian student community. There is a lack of awareness in India about opportunities offered by German universities. Despite this, the number of Indian students in Germany has tripled since 1999 to over 4,000! At the International Max Planck Research Schools, Indian students are the biggest group of foreign students. Many are not aware of it, but today language doesn't have to be an issue for Indian students who speak English and would like to study in Germany. This country now attracts Indian students because of the high quality of German universities and about 500 new academic courses held in English introduced at German universities over the last few years. I myself am fully funded Research Fellow pursuing advanced research in Global Climate Change (which along with Geology and Oceanography is another field of German collaborative interests) under the DAAD Fellowship. German Academic Exchange Service (DAAD) continuing their efforts to promote academic studies in Germany. The DAAD is running an office in New Delhi for this purpose.

The procedure for the scholarship had already begun when the applicants filled the application time we received almost 250 forms. This applications!! The girls enthusiastically shared their experience about the entire scholarship process. Most of them had filled up the form themselves. But some girls confessed that they took some help from friends, relatives or parents. The Statement of purpose particularly was of great concern. LPF trustees screened each and every application form to mete out justice to each. LPF follows a systematic process involving tremendous labor, from screening, to scrutinizing, to debating and discussing each individual. Every trustee's views are considered, every small detail analyzed. Each Lila fellow is evaluated and cross- examined by all trustees. After knowing and been a part of this evaluation process we have understood how much goes into choosing a Lila fellow, so we all should be proud of this fact and always believe that we are really special and hence a part of LPF. The new girls were glad for getting an opportunity to attend the interview and face the panel of trustees. The interviewees were from myriad educational fields such as physics, chemistry, biology and computers. Pharmacy was particularly popular because the fees for M.Pharm were surprisingly high and competition was tough said Shubhangi, Tanmayee, Anuja, and Snehal who were going to pursue their Master's degree in this field.

How did they learn about the LPF? The most common source was the newspaper. Some girls

learnt about the scholarship details through their college notice boards, Radio Mirchi, senior Lila Fellows & relatives.

# LEADING LADY

ith over 45,000 students on campus and a lakh in distance learning programmes, along with an annual turnover of Rupees 140 crores, DR. VIDYA YERAVDEKAR, Joint Director of one of the country's largest educational empires, Symbiosis converses with Lila Fellow, PRADNYA KASHIKAR .....

Symbiosis has a total of 26 different institutions imparting quality education in disciplines such as Foreign Trade, Information Technology, Mass Communication, Computer Studies, Management, Law, Arts and Commerce etc. with a total 127 courses. Dr. Vidya Yeravdekar is presently looking after the management and administration of the Symbiosis Society, which is an educational Institute of over 31 years of reputation. An Health Entrepreneur and Health Education Award winner, recipient of Pune Ki Asha Puraskar by Asha Foundation, a gynecologist with an additional degree in Law and now administrator of a well-known institute, Dr. Vidya, humbly shares her experiences with a smile on her face.

# ON CONNECTING THE TWO DISCIPLINES OF MANAGEMENT AND MEDICINE.....

"SYMBIOSIS has become like another sibling. Today, it has 33 institutes, from school, graduate college and specialized fields like law, media, IT etc. When my father, Dr. S. B. Muzumdar started the institute in 1971, he didn't have enough money to buy land. So Symbiosis actually started from our house. As a kid, I would see foreign students living in with us because we did not have a campus. I grew up like any average kid with a modest background. We lived in the campus of Ferguson College, Pune, as my father was a professor there. My ambition was always to become a doctor. I enrolled in the BJ Medical College, much against my father's wish. He wanted me to pursue either the Indian Foreign Service or the Indian Administrative Service. My mother, Sanjivani Mujumdar, supported my goal. But I guess I was destined to do what my father wanted me to do. In 1996, I joined Symbiosis and eventually got involved with its administration."

#### ON JOINING THE FAMILY'S TRADE.....

"I was working in Oman (1992-96) with the Ministry of Health when I realized the importance of health awareness programs in the community. So when I returned, I did not want to start just another run-of the-mill hospital. In India, till then, no one had ever considered the potential of health education. So I put forth the idea of commencing a health-science department in Symbiosis. I had to make a proposal and get it passed by the Board of Directors then. Of course, they were skeptical. They questioned my

commitment and I had to prove that I'd come back with a purpose — to serve an educational institute in the capacity of a medical professional. I worked as the Director of Symbiosis Centre for Health Care for two years initially. By 2001, I was promoted as the Joint Director."

# ON HER CONTRIBUTION IN HANDLING THE SHOW....

"I take care of the daily operations of all the institutes and the admission procedures. I'm a member on the

Board of Symbiosis Deemed University and a part of the Planning and Development Cell. I also handle the international promotions. We have a base in Dubai and are opening a campus in Mauritius. We've just acquired 300 acres of land in Pune, which will be called the Symbiosis Knowledge Village and have plans of setting up a Medical College, the Medi-City in 50 acres. This will be executed by 2006. But I want the brand-name 'Symbiosis' to be present in Africa, the Middle-East and the South-East Asia. I want it to become one of Asia's top 10 universities."

#### ON BEING A WOMAN BOSS...

# Jonathan Livingston Seagull a story

This is a story about people who follow their dreams and make their own rules; a story that has inspired

people for decades.

The author Richard Bach is a former US Air Force Pilot and has a passion for airplanes. He has authored three books on the mystique of flying and during the past decade has edited a flying magazine, and written more than hundred magazine articles and stories.

This story is about Jonathan Livingston, an extraordinary Seagull. For most seagulls, life consists of just eating and surviving, where flying is just a means of finding food. However, Jonathan Livingston discovered that for him, "flying was life itself". Against the conventions of the seagull community, he resolves to seek a higher purpose and become the best at doing what he loves.

Jonathan loved to fly; he always wanted to discover in his god-gifted wings the potential to fly, and not just acquire food for him. He was driven by an urge to learn, discover to fly to be free; to be different, unlike the non-motivated, conventional and conservative seagull community. He was resultantly outcaste by the Seagull society. Jon, unashamed still practiced flying trying hard to learn what he could do in air. Jonathan first set a world speed record for Seagulls! He realized- 'We can be free! We can learn to fly!' He spent the rest of his days alone, but he flew way out and beyond. His one sorrow was not solitude, it was that other gulls refused to believe the glory of flight that

awaited them; they refused to open their eyes and see.

He learned more each day till he met a flock of some other seagulls which had come to take him higher, to take him home. LF Priya Lele, currently researching in commercial law at the? Centre for Business Research, University of Cambridge shares her experiences and gives an insight into the many options law has to offer to promising young aspirants.

#### Fancy a career in law? - rest assured sky is the limit!

here are two kinds of reaction that I encounter when I introduce myself as a 'corporate/commercial lawyer' when in India mostly that of a puzzled expression, keen to understand what that means and which courts I attend. And when abroad, that of awe or respect, may be not so much for the knowledge that it assumes I possess but for the imaginary handsome figure that people think that I may be earning (which is not true by the way).

Growing up in a family of lawyers it was perhaps natural for me to develop fascination for a career in law. From the time that I could speak up my mind, which unsurprisingly I started doing rather early, I knew and always told everyone that I wanted to be a 'Lawyer'. But it wasn't until I grew up and finally started studying at a college of law that I realised the different options that I had in the profession.

These days kids are probably much smarter. Now, please don't assume I am ancient, but in the jet-set age of the internet, five years into the profession (and ten years since I started studying to be a lawyer) is a long time. But I knew little apart from what I'd seen my grandfather and parents do as lawyers: i.e. to wear really smart looking black coats and white bands on white shirts (or whitish silk sarees as in case of my mother) and go to courts. It wasn't until I joined the chambers of a renowned civil lawyer in Pune while studying for a degree in law, that I slowly learnt what that involved, besides dressing up smart and also learnt of other possibilities that the profession held for me.

As a law student at the prestigious institute of 'ILS Law College', my ambition to wear the black coat and argue in the courts lead me to participate at a number of moot court competitions - i.e. where you argue on a hypothetical legal case as a counsel before a panel of judges. Winning the national moot court competition in 1999, I was still determined to make it at the bar (not at your local bar - but practicing in litigation as a counsel appearing before the courts is often referred to as 'practice at the bar'). Somewhere, between 1999 to 2001 this determination withered away, partly because of

having realised the harsh realities of litigating practice through my stint at the local civil law chambers and partly because of developing a particular liking for corporate2 and commercial laws3, for which

there is more scope in Pune than on the litigation side of the profession. Therefore as a fresh pass-out from Law College, I, like many others dared to venture into a career in a law firm in non-litigation practice, mostly transactional.

Exciting and challenging as the profession of law may be, I do not wish to paint a rosy picture. Litigation (and sometimes even arbitration) side of the practice can especially be frustrating because of the delays in the judicial system. Any layman, let alone a legal professional, would tell you that 'Justice delayed is justice denied'. Yet, in India we find millions of people losing the financial and temporal battle of litigation everyday. So if you fancy a career at the bar, be prepared! 'Patience' is probably the most important skill you'll need to possess as no amount of legal acumen and knowledge would help you keep up your spirits and remain focussed through endless adjournments and delays at the courts/tribunals. Sadly, arbitration could also prove daunting. I've got etched in my memory an unforgettable experience of being involved in a very exciting commercial arbitration, which failed to even take off because of abuse by the other party of the law relating to appointment of arbitrator/s.

But hang on a minute; I do not want to dissuade you from one of the most exciting fields of law either. When you finally do get your chance before the courts, it's worth every minute of your wait. The sheer pleasure of battling it out or should I say, roughing it out before the court with real life litigants is unimaginably rewarding (and once you've established yourself at the bar the financial rewards can be more than pleasing).

So, while a career at the bar, when you finally get the chance to build your case before the court, is sheer adrenaline-pumping, career as a non-litigation legal professional is no less fun. In fact, I would any day prefer the later to the former. For 'patience' is not one of my virtues (not that I have many...ahem, ahem).

I was very fortunate to have joined Dua Associates, a national law firm, specialists in corporate/commercial laws at the right time of their expansion in the Pune office. We being a young and small team of five lawyers, (and thanks to my liking for corporate /commercial the better part got matters,) corporate/commercial practice in Pune. As a budding lawyer at the firm, I was also given extensive exposure in their other metropolitan offices. As a young lawyer in a law firm, I soon realised that what I had studied in the law college as 'law' was the 'law on books' and now I had to develop the skills of interpreting and applying the 'law in practice' - something that you learn only on the job.

Non-litigation side of practice in India includes transactional side of Mergers & Acquisitions, IPOs4, foreign investment in India etc. These are mostly done in Mumbai and Delhi. I was involved in Due Diligence exercises for acquisitions and mergers in Mumbai and Delhi and also in advising international clients on their investment options and on the applicability of Foreign Exchange Management Act, 1999 to their investments in India. But being in Pune, my profile mainly involved drafting commercial documents and agreements for corporate clients including share purchase and shareholders agreement, venture capital investment agreements, joint ventures, business alliance, franchisee agreements and so on and giving advice to them on application of various commercial laws to their businesses.

The best part of being a corporate/commercial lawyer (apart from flying high and staying and dining at five star hotels) is, I think the opportunity to interact with managers and business people and to come up with solutions for their 'businesses'. I soon realised that as a modern corporate/commercial lawyer, one has to also acquire and develop managerial skills and business acumen. Besides, they say 'law is a jealous mistress'. Yes, you guessed it right, like any other profession a career in law requires total commitment, persistence and passion for work. So all in all it's an exciting but tough profession.

Whilst working with a law firm in its non-litigation practice is exciting, one may ask, 'how is it practising as a

non-litigation independent legal professional?' I am glad to offer some insights in this too. At least for a short while I've had the most wonderful experience of independent non-lit practice in Pune. Unheard of? May be. It's definitely rare for a legal professional to go solo in commercial and corporate non-litigation practice, that too in the first three years of her practice. Whilst litigation lawyers tend traditionally in India to independently, non-litigation practice is almost entirely the arena of law firms - big or small. Thanks to the individualistic style that I had built up at my erstwhile employer, finding work was never a problem. Finding time to do the work was a challenge, though. From being the well groomed and looked after associate in a national law firm, I was suddenly going to client offices more often for meetings (mainly because I didn't have a fancy conference room to offer), self-driven of course, printing, photocopying, answering calls and even faxing my own communications and even going and recovering the bills of costs (which was mostly a pleasant experience thanks to my clients but a bit awkward to say the least). All of this meant that I was working pretty much 24/7 to deliver the work in time. Plain, simple exhausting, but highly rewarding!

If I would not have got the opportunity to do my masters (LL.M.) at the University of Cambridge, fully funded by the Cambridge Commonwealth trust<sup>6</sup>, I am sure I would have continued my private practice in Pune. But the LL.M. at Cambridge changed my career path once again7 and so to say changed my life.

I came in the year 2004 to Cambridge to pursue my LL.M. with a view to developing my career in International Commercial Laws and returning to practice. After completing my LL.M. successfullys, with a Cambridge Pegasus Scholarship for the year 2005 I also got the amazing opportunity of doing month-long internships with three reputed Barristers' Chambers in London last year. But it was really the academia that attracted me the most. Studying with the stalwarts in corporate and commercial laws at Cambridge has enhanced my outlook towards the academia. A career in academics and research in law is what I am working towards at the moment. I realised that there is so much more to law than to just interpret it for the courts as in litigation (or arbitration) practice or apply it for your clients as in non-litigation practice. There is a lot of scope for reading into the law as it is, theorising on how the law should be or ought to be and researching on ways to achieve it - i.e. on ways to make it better.



Finally, there's another aspect to the profession of law that I am now exploring— academic research. If you thought doing academic research in corporate laws is boring, think again!

I am currently involved with a very ambitious inter-disciplinary project on 'Law, Finance and Development'. Working with distinguished corporate lawyers and economists at the Centre for Business Research, this project aims at finding the mechanisms by which legal institutions shape national financial systems, so as to identify the implications of legal reform for economic development. My role in the project is a more humble one of constructing indices for shareholder protection and creditor protection (and at a later stage possibly employee protection) law in India and some other countries with common law legal system9 across the time-series of 1980-2004. All this legal data would then form part of further econometric 10 study to find any correlations between legal data and economic data of countries. I would also be playing an important role in detailed case studies of some of the identified countries involving inter alia interviewing experts and business people from various fields to capture their perspectives

on how changes to law across time-series have affected economic development of the respective countries.

Hang on a minute, now I was talking about researching on the 'idealised' law and now I am discussing giving numbers to the law? Sure, it is baffling for the uninitiated to think about assigning numbers on a scale of 0-1 to legal provisions from different countries to compare them. This is a new and emerging field of comparative law – that can be referred to as 'leximetrics'.11

Having studied at the best University in UK and the second best in the world, I have thus become aware of some path-breaking and emerging fields of law. My current research falls broadly in the emerging field of 'law and economics' 12. My paper hopes to contribute to the growing literature on 'law and finance' 13 and experiments in 'leximetrics'. Who knows where the fascinating world of 'law' might take me next. There are several new fields of study emerging every day in the 'profession of law' and I aim to find and pursue new paths on my journey through the exciting profession of law. So, if you, like me, fancy a career in law, rest assured, sky is our limit!

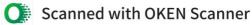

I am an economist working for an NGO and I find my career unconventional, challenging and satisfying. *Now, what was that?* Yes, you read right.



Unconventional careerist Economist for NGO-Anagha Mitra

Its 'unconventional', because I feel, at birth every individual is gifted with something. But somehow our education and social system kills originality over the years and somewhere we as individuals get lost in this system. I realised at a very young age that I

was inclined towards writing, travelling and working for social development. So, I decided to take up Arts specialise in economics. Generally, development sector is dominated by professionals from social work and field of sociology. But economics as a social science gives you a holistic view. Thus, I chose something unconventional because not many economists can be found in the field of social upliftment. You find economists working with banks, RBI or doing a Ph.D and working in academic institutes, teaching or working on defined research projects, or then some like Dr. Manmohan Singh plan our country's future! As I followed my heart in pursuing a career of my choice, I had the works of great economists for guidance.

"Globalization today is not working. Its not working for many of the world's poor. It is not working for much of the environment. It is not working for the stability of the global This is a quote by the famous economy." economist Joseph Stiglitz from his Globalization and Its Discontents. And to some extent the statement holds true. 'Economics' for most economists ends up becoming



mathematical calculations and models which might not work in the real world. BUT real world problems deal with human beings. Having realized this, I consciously opted for a discipline termed 'development economics', which would give me the best of both the worlds - mathematical economics and the sociological implications of economics. The proponent of this subject is Prof. Amartya Sen. Given the context of a developing economy, if the above quote holds true, then there is obviously a divide between the 'haves' and the 'have nots' created by this myth of globalization. A divide which is ever increasing between the beneficiaries of globalization and those who are marginalized. A divide which becomes very centric to people's needs and desires which thus cannot be very easily fulfilled. To a great extent this is due to policy lacunae and implementation problems at grassroot levels. In this context, Prof. Amartya Sen has argued that people die of hunger not because of unavailability of food in the country but primarily because of lack of proper distribution networks and information dissemination in the country. Through his argument, Sen has pointed out that quality of lives should be measured not by the wealth of a country but by the freedom, justice and dignity the country gives to its people by protecting their human rights.

Thus, believing very strongly in these principles I decided to choose a career which was along the lines of learning by doing and experiencing the real world. I learn only if I travel and go to rural areas and interact, place this data and knowledge into the economic theories and social science practices. Without this exercise, knowledge would mean nothing. India is a rich country. Our rural areas especially have so much to offer that for a Social Scientist it acts like a laboratory to enable research. So, I call this 'practical' and not theortical work. Understanding the dynamics, the cause and effect are the most interesting features in building a career in the Environment/Development Planning sector within the Indian context. An opportunity for constant learning and application is a part of this sector. An everyday learning by doing is what this sector offers. Playing a role of leadership is a key of moving ahead.

As a development economist there is a great sense of satisfaction as you are actually in a way helping

Universities and the people with your skills. industry sectors in India are also realizing the importance of social science stream and its importance per se in overall planning.

I was awarded the Lila Poonawalla Foundation scholarship in 1996 for doing my Masters in Economics at Gokhale Institute of Politics and Economics. After completing my Masters I worked for a NGO named Development Support Team in Pune for two years. The work at this NGO was research oriented, focusing on development issues related to urban and rural microfinance.

I got a LSE Research Studentship in 2000 for studying M.Sc. Public Policy and Planning at London School of Economics. The very close tutor-student interaction during the course was an educative experience unlike any conventional Indian curricula. While studying at LSE, I wanted to understand how the NGOs abroad work and how are they different from NGOs in India. I was selected as a Research Intern with a British NGO named 'WAR on WANT' which works with rural communities and underprivileged informal sector workers in developing countries. This is a London based NGO which supports the work of Community based organisations in India and Latin America by way of providing grants. One such grant was extended to an organization in Mumbai which is working for rag pickers. These rag pickers are children or women who are either destitute, widowed or divorced. 'WAR on WANT' gave me the task of writing a strategy paper on this Mumbai-based-organisation, on the basis of which they would decide whether they would continue funding their work. My work involved travelling and meeting the Head of this Organisation, interacting with the staff, understanding their work,? their vision and if they had the clarity about what they wanted to do. This work in a way requires the skills of reading peoples minds as well, because its not uncommon in my job to come across people who lack vision.

After returning to India in 2002, I continued to work with various stakeholders in the development process. I work for a consulting company named Emergent Ventures India Pvt. Ltd. It is challening indeed as I work as a Freelance Consultant which means right from business development to



negotiation of fees and project execution, I handle everything. There is a huge scope for learning. One makes mistakes but then to do something different one has to take risks and that is what I am doing. Everyday is a workfloor where I appy new ideas. I enjoy what I do.

When I say 'helping with my skills', I mean, I write well and I have a penchant for researching development issues. So my services are helpful to NGO's. For example, there is a national level NGO in Delhi named PRADAN. I undertook a research on tribal women. PRADAN has a microfinance project. Over a period of ten years the NGO had observed that there were a number of drop-outs from this project. They wanted to understand the reasons. The project was located in a tribal area around Purulia in West Bengal. So, I travelled to this place,

researched and then wrote a paper on this issue. Here my skills as an economist came handy in designing the research and since I like to write I wrote a paper which many in the development sector could read. This worked towards 'information dissemination'. It was most satisfying to learn that I could contribute with my skills in a meaningful way! And yes, this is not honorary work, the NGO's pay for this service.

This is a career which is quite unconventional, challenging and satisfying. A career which gives one an opportunity to interact at all levels. Above all, it gives you an opportunity to understand that there are people in this world who don't possess anything, and you as a professional with your expertise can make that little precious change in their lives.
