Year 2017-2018 was also one of such year with full of exciting activities and opportunities to prove LPF is best. We are very delighted to proclaim that this year also Foundation has continued its noble work of educating and empowering academically clever but economically challenged girls, largely from rural areas of Pune, Amravati, and Wardha Districts. In the year 2017 alone, Foundation welcomed 1548 additional daughters to LILA Family in 7 grand functions. A year was full of grand celebrations, functions, events, almost in every month something stimulating happening and continuing journey towards LPF mission -Leading Indian Ladies Ahead. Now looking forward to one more successful year i.e. 2017-2018 with aspiration of helping more and more number of girls and enable them to realize their dreams. What was planted as a seed of hope 22 years ago in 1996 by holding hands of 20 girls is now blossoming into a tree by having family of over 7396 girls."

History of the organization:

Lila Poonawalla Foundation (LPF) was started in 1996. It is the 22th year of the Foundation. Prominent educationists from Pune form the highly motivated team of trustees of the Foundation, which is a registered charitable trust (October 9, 1995).

The students are gifted with an outright grant of up to a maximum of rupees one lakhs per year for completing their UG and PG education in various fields for entire period of the course be it two years or three or four years.

Firstly, in the 15th year, the Foundation introduced scholarships for undergraduate studies for engineering in any stream, with the goal to support these girls for four years to complete their course. Secondly, in the 16th year, the Foundation launched yet another new initiative that of extending scholarships also to undergraduate girl students in any of the pure sciences streams. Also, the Foundation took a very big step forward and started with school scholarships. Till now Foundation supported total 1498 girls from 19 schools. These girls are selected from 7th standard and the Foundation will support these selected girls right through their post graduation. Every year, around 250 to 300 new girls will be added. These girls are not only supported economically for their fees, uniforms, shoes, books etc, but are given extra coaching and counseling, the teachers of these classes are given special training with the objective of building excellent teaching capacity. The parents of these children, especially the mothers are given education in health and hygiene as well as overall awareness of their rights, and the importance of girl child education. Thirdly, in the 17th



year, Foundation, in addition to Engineering and Science, introduced courses like Physiotherapy, Nursing, Architecture, Diploma in Engineering, Diploma in Education and Pharmacy for a period of two to five years, depending on the selected course. This was a big step forward for the Foundation. These scholarships are outright grants to the brilliant, yet economically needy girls, many of whom come from rural areas. Fourthly, in the 19th Year the Foundation took another bold step and along with Pune District expanded its noble work of awarding scholarships to the Girls with outstanding academic records, but economically needy in two new districts of Maharashtra i.e. Wardha and Amravati. Fifthly, in the 20th year the Foundation broke its record and awarded total 1190 scholarship in a year to the girls from Pune, Amravati & Wardha districts. From inception, until now, the LPF has already given over 17765 scholarships, supporting approximately 7396 young ladies (1212 for post-graduation studies in India and abroad, 4686 for undergraduates in India and 1498 in the school program).

This Foundation is unique in a way that it makes an all-out effort to communicate regularly with all the Lila Fellows, Lila Girls, Lila Juniors through a quarterly newsletter called 'INSPIRA' and also through an e-group, no matter in which part of the world the young girls are either studying or working. The Foundation is regularly conducting many training programs for the girls, including spoken English, to ensure they grow into empowered, confident, yet gentle, young ladies.

Vision (What the organization is aiming to accomplish)

Lila Poonawalla Foundation (LPF) is an Educational Trust in India with a vision to contribute to the Empowerment of Indian Women by supporting academically outstanding and financially challenged girls, Through Grant Scholarship to pursue higher education.

Mission (What are the strategies for making this happen)

Based in Pune, LPF's main aim is to support academically clever but economically challenged girls pursue their education. In Maharashtra where lack of literacy amongst the masses, especially the female population, is an ongoing phenomenon, LPF's mission is to enable socially deprived and financially disadvantaged ladies pursue professional degrees and become economically independent and confident girls, who can not only earn for themselves but also take care of their families.

Understanding that degrees, just aren't enough to sustain a livelihood, LPF aim's to work towards mentoring the awardees, which in turn will enable them to enhance their skills and get better employment opportunities.

Empowerment being the crux of the Foundation, LPF's ultimate aim is to empower ladies, so that they become financially independent and productive individuals who will work



alongside men whereby reshaping the traditional gender norms and bringing equality in interpersonal and social relationships, thereby promoting gender equality.

Objectives of the Lila Poonawalla Foundation

1. Promoting Education of girls

As education is the base for a strong and successful career, it is the objective of the Foundation to promote education of girls.

In a typical middle-class Indian family, when the girl completes 10th or 12th std. and wants to go for course in science, Engineering or after her graduation want to do higher education, she finds it difficult to find the resources for her education. The middle-income family's limited finances allow a different set of priorities – parents' medical needs, family's expenses, son's education (which gets preference before the girl's) and the girl's marriage (expenses as well as dowry demands). In this process, very often the girls' dreams are lost. Foundation gives an outright grant to the girls with outstanding academic records, but economically needy to purse graduation or post graduation. This financial support encourages girls to pursue education further and also complete it successfully.

2. Develop and Empowerment of Girls / Provide support for overall personality Development

Besides financial support for education, the Foundation ensures girls grow into empowered, confident, yet gentle, young ladies. So LPF regularly conducting many training programs for the girls, including spoken English, personality development, etiquette and mannerism, awareness of good health and hygiene, self defense, stress management, confidence building, career guidance, and many such programs.



3. Makes girls economically independent

Education equips them to get good employment which makes them economically independent. Also economic independence of the girls not only make them stand on their own feet and support themselves but also support their family.

4. Promote gender equality

Girls will be financially independent and work alongside men in different areas whereby reshaping the traditional gender norms and bringing equality in interpersonal and social relationships.

Expected Outputs of the Foundation are as follows:

- ✓ Higher education for academically talented and poor girls
- ✓ Life Skill and mentor support to enhance employability which leads to economic independence
- ✓ Holistic development of the girls

To measure progress on above mentioned 'Expected Outputs' following are the Key Performance Indicators (KPIs):

- ✓ Successful progression, performance and completion of the course
- ✓ Increased self confidence, communication, problem solving , technology skills and enhance employability
- ✓ Job placement and increased individual and family incomes

We have appointed an external agency M/s Goodera, as our Monitoring & Evaluation consultant. The scope of this assignment is as follows:

- ✓ Deployed Goodera platform for conducting baseline, end line and program lifecycle management.
- ✓ Deployed mobile app-based reporting system for girls about their academic performance, extra-curricular achievements and engaging with the Foundation. Embarked on a cloud-based Monitoring & Evaluation system with customized dashboards for analytics
- ✓ Developed a system to capture and analyze pre-& post training feedback from the girls. Gradually planning to digitize this process through Goodera's mobile-based application



We have accomplished in this year...

From inception, until now, the LPF supported more than 7396 young ladies (1212 for post graduation studies in India and abroad, 3033 for undergraduates in India and 1498 in the school program). In the year 2017-2018 Foundation supported 1548 girls (113 for post graduation studies, 1065 for undergraduates and 370 in the school program) Foundation continuously arranging Life Skill and mentor support through various training programs. This year Foundation arranged 226 training programs for the recipients.

Since 2011, supported girls from 14 schools under "2morrow2gether" and in 2016-2017 added 5 new schools.

Since 2008, provided 'Wholesome Development and Sustainable Leadership Program' at ASHA Centre, UK to 94 girls and in 2017-2018 trained additional 24 girls.

We wants to accomplish...

Till now we are persistently working towards our mission of supporting girls of Pune, Amravti and Wardha district only, and we have started to give scholarship to Nagpur in 2016 year however our aim of working in other parts of Maharashtra not yet accomplished due to limited resources and infrastructure.

CREDIBILITY ALLIANCE is a consortium of Voluntary Organizations. It is an initiative that emerged from within the sector and was registered in May 2004 as an independent, not-for-profit organization. Credibility Alliance has gone through all our procedures and method of giving the scholarship. Credibility Alliance has praised us for running the Foundation with transparency, honesty and dedication.




Placements




Pie Chart of Placements






















Pie Chart of Amravati Placements (2014 Onwards)
